What's on in Peasmarsh	5&6	

The Peasmarsh Neighbourhood Development Plan is still on hold, awaiting the Examiner's final report following the public hearing in September. There is therefore no further story inside.

There was a mistake last month in that we noted that the current developer of the Pippins site had not made a formal planning application when, in fact, he had. That was caused by a glitch in the Rother notification system.

The period for commenting on the proposed plans has now passed.

The overall plot plan submitted for the formal planning application is identical to that submitted to the parish council a few months back so nothing has changed in principle. The application does, however, now provide more details than were available previously.

RDC has received 85 letters and 26 online submissions from members of the public, all of them apparently objecting to the development.

Our parish council [PPC] also submitted an objection document on our behalf. The full text can be seen online :

A summary of the key objections made by the council is as follows :

Road Access

There are two aspects challenged : the junction with Main Street and the very narrow road through to the development proper.

The Main Street junction requires a 'build-out' which will reduce the width of Main Street. The application is based on data collected during lockdown. In addition, ESCC's estimate of 178 vehicle movements per day seems extraordinarily low given deliveries, tradespeople and so on. There is also no consideration of the effect on the neighbouring properties. PPC also points out that permission was refused for a development over 50 years ago [when traffic was minimal], in part because access 'would cause interruption in the free flow of traffic and increase traffic difficulties and danger'.

The narrow road issue – which would require a shared surface – was well aired two years ago but the number of properties is now 41, not 29, so over 40% more dwellings. However, this application no longer includes the pedestrian refuges which were a feature of the 2021 application.

Pedestrian Access

The council also addresses what the application calls a <u>stepped</u> connection to the footpath [it is not a public right of way] at the east end of the site : it will not be usable by people with prams or mobility devices.

Affordable Housing

As is well known from the work undertaken in preparing our Neighbourhood Development Plan, one of the greatest needs in the parish is for truly affordable housing. The withdrawn 2021 application included 40% affordable housing as required by the Rother policy LHN2 and enshrined in its 2019 decision to develop the Pippins site.

PPC therefore objects to the current proposal having <u>no</u> affordable housing element on the grounds that it would make the scheme 'economically unviable'. If it is that easy to override such fundamental requirements what is the point of having the policy?

Surface Water Drainage

When the current proposals were first brought to the council's attention it was assumed that having access rights to a 'third-party watercourse as the discharge point' meant the drain which runs under the lane to the east which joins Main Street below Griffin Hall.

The application itself no longer does that but claims that there is a water course along the eastern boundary of the site. PPC points out that there is not, as has been demonstrated by the flooding which occurs regularly below the site. Where would such a water course go?

Sewage Disposal

The council again challenges the poor quality of our sewage disposal infrastructure and its ability to cope with another 41 dwellings.

Construction Disruption

PPC is concerned about the disruption and potential damage caused during construction – which will demonstrate how poor the connecting route to the main part of the site really is. It particularly highlights the need to stop parking on Main Street : all parking must be on site.

There are other issues also addressed by the council as can be seen in the original document [see link on the previous page].
